NEW BUSINESS

- Algae Testing – Brian Lind, Applied Biochemists will be sending a test kit and instruction to the CLA within the next couple of weeks. Cary Poston will take a sample when there is an algae bloom in the lake and ship it to Applied Biochemists who will identify the predominant algae and test it for sensitivity to several algaecides registered in the state of Idaho. This test will be provided by Applied Biochemists at no charge to the CLA. Algaecide application permit requirements are under review by the state at this time.
