- Cocolalla Lake Milfoil Treatment update: There is still not update. We continue to expect ISDA plans to survey our lake in June. At that time a final treatment plan will be formulated as to diver hand pull or herbicide treatment depending on the outcome. The soonest they will be able to begin treatments would be approximately the middle of July.
